Development News

30th Anniversary – As the oldest 501(c) (3) non-profit in Del Mar, the Del Mar Foundation will celebrate its 30th Anniversary in 2012. Through the generous support of the Founding Endowment Circle, donors have successfully funded a Del Mar Foundation Community Endowment Fund that today is worth well in excess of \$500,000. In celebration of the 30th Anniversary, an active effort has been implemented with the support of Board Members to increase the Endowment to \$1,000,000 with additional funding from the community. This will allow the Del Mar Foundation to contribute funds in support of larger community Grant projects that will serve to make a meaningful and significant community impact.

Legacy Society – As part of this active effort, in January 2011, the Del Mar Foundation introduced the Legacy Society as an easy option for gift planning purposes. By naming the Del Mar Foundation in an estate plan donors can bequeath a legacy in their name to the Endowment through a variety of funding options. As Del Mar's oldest 501(c)(3) non-profit, the Del Mar Foundation sponsors programs, makes grants, and manages over \$1,000,000 in endowment funds to benefit the community and the San Dieguito Lagoon. The community endowment provides long-term funding stability for community needs.

Best known for our Summer Twilight concerts, First Thursdays cultural arts series, and children's events such as the Easter Egg Hunt and 4th of July Parade, the Foundation sponsors a wide array of community programs. The Foundation also contributes financial support to community organizations and projects such as the Del Mar Library, Lifeguards and the Beach Safety Center, the Del Mar Garden Club, Del Mar Community Connections, and the Shores acquisition. Over the years, the Foundation has also served as an incubator or fiscal sponsor for many of the present day non-profits that so greatly enrich our community.

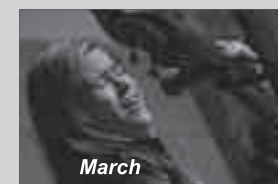
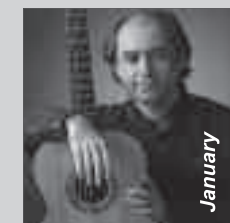
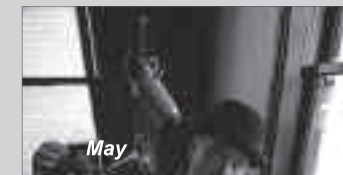
